New metering project underway

A FEW MONTHS BACK, I wrote an article about the new metering system that would be deployed in the Adams REC service territory. Our intent was to start installing the new meters in the last part of April, but due to a delay in one of the main components of the infrastructure, we didn't get underway until mid-June.



Some of you reading this may already have a new meter, while others who receive their electricity from our Panhandle Substation will be getting theirs in

The first phase of our deployment will include all of the consumers on our Panhandle Substation, which totals about 1,600 meters. Once finished with Panhandle, we will move on to another substation. These new meters will not only bring in daily readings and, if need be, on-demand readings, but they will also monitor voltage and can alert us if a transformer is overheating.

Today, when we experience an outage, we have to call a consumer or send someone to check meters to make sure the power is on. The new meters have the capability for us to send a signal, called "pinging," and in a matter of seconds we will know if a meter has power. The new metering system will integrate with our outage management system and, in some cases, alert us to a power outage before a member even calls. 3500365500

The new metering system is the final piece of the puzzle in new technologies that we have invested in over the last four years. These investments not only assist us in continuing to provide safe, reliable electricity to your homes and businesses, but also aids in the restoration of outages. When a major storm or weather event hits, the new system will be especially beneficial as a valuable addition to our geographic information mapping system, outage management system, and automatic vehicle location program. All of these pieces together will assist us in quicker restoration times.
